

GENERAL INFORMATION

At COLORADO SPRINGS all southbound trains will arrive at and depart from Denver & Rio Grande Western Station. All northbound trains will arrive at and depart from Atchison, Topeka & Santa Fe-Colorado & Southern Station.

At Colorado Springs trains of the Chicago, Rock Island and Pacific Railway arrive at and depart from the station of the Denver & Rio Grande Western at the foot of Pikes Peak Avenue.

All local tickets of the issue of Atchison, Topeka & Santa Fe, Colorado & Southern, and Denver & Rio Grande Western and inter-line coupon tickets carrying coupons reading between Denver, Colorado Springs and Pueblo proper will be interchangeable and honored for passage on all trains.

Local tickets and inter-line coupon tickets reading between Denver, Colorado Springs or Pueblo and points intermediate to Denver and Colorado Springs or points intermediate to Colorado Springs and Pueblo will be interchangeable as between A. T. & S. F. and D. & R. G. W. but will also be honored on C. & S. trains.

Local tickets and coupons of inter-line tickets reading to or from points beyond Denver or Pueblo will be honored only as they read, although tickets reading over A. T. & S. F. and C. & S. will be good on A. T. & S. F. and C. & S. trains, except that tickets reading over C. & S. will not be good for passage to or from any point other than Denver, Colorado Springs or Pueblo.

The Atchison, Topeka & Santa Fe, Colorado & Southern and Denver & Rio Grande Western will not be responsible for errors in time tables, inconvenience or damage resulting from delayed trains or failure to make connections; schedules shown herein are subject to change without notice.
