### **INSTRUCTIONS**

- 1. Before starting engine, crew will inspect the unit checking oil and water level, fuel supply, lights, angle cocks, brake shoes, piston travel, couplers, and cut levers. Look for any loose or broken equipment.
- 2. When shutting engine down for the day, crew will again inspect unit advising office of any problems that need correcting. Reverser lever will be removed from unit and cab locked. The stack should be covered.
- 3. Crew will observe track conditions and report any problems to Agent daily.
- 4. Crew will report any equipment problems to Agent daily.
