


PEND OREILLE VALLEY RAILROAD

General Information

Freight service on POVA is one train from Usk (Milepost 16) to Newport (Milepost 0) daily, with others as needed.

Engines, trains or other equipment may not exceed a maximum speed of 25 miles per hour on Pend Oreille Valley Railroad. Except when changed or superseded by bulletin or Special Instructions, Pend Oreille Valley Railroad operates under a code of operating and safety rules and under an Absolute Block.

Definition of an Absolute Block:

A length of track in which NO train or engine is permitted to enter while it is occupied by another train of engine, unless authorized by train order.

Pend Oreille Valley Railroad will operate two (2) subdivisions under this Absolute Block:

First Subdivision: Includes all trackage from milepost 15 south to milepost 1 at Newport yard limits.

Second Subdivision: Includes all trackage from milepost 17.5 north to milepost 59.8 at Metaline Falls yard limits.

A train register, labeled "ABSOLUTE BLOCK, First Subdivision:" and "ABSOLUTE BLOCK, Second Subdivision:" will be located at the POVA shop. Before leaving the Usk yard, the Conductor or Engineer MUST register on the appropriate register form for each respective Subdivision. Upon returning to the initial terminal the Conductor or Engineer must register in the same manner.

All movement on main line, monitor & transmit on POVA's Channel 1 & 2

Special Instructions

- S-1 Engine, train or track equipment moving north out of tracks #2 or #3 in Newport Yard must wait 20 seconds after activation of lights before proceeding over crossing. Make certain crossing gates are in the down position.
- S-3 All trains must proceed at restricted speed at the following locations:
 - 1 Through Blueslide Tunnel between MP 38 and MP 39
 - 2 Over Box Canyon Bridge WN 100 between MP 54 and MP 55
 - 3 Between Vail Tunnel MP 55.6 north to Metaline Falls yard limits
- S-4 Where derails have been installed Derails must be left in derailing position and wheel chocks must be in place when cars or engines are on spot.
- S-5 Trains will not exceed 10 m.p.h. over all passing track, sidings and spur tracks on POVA
