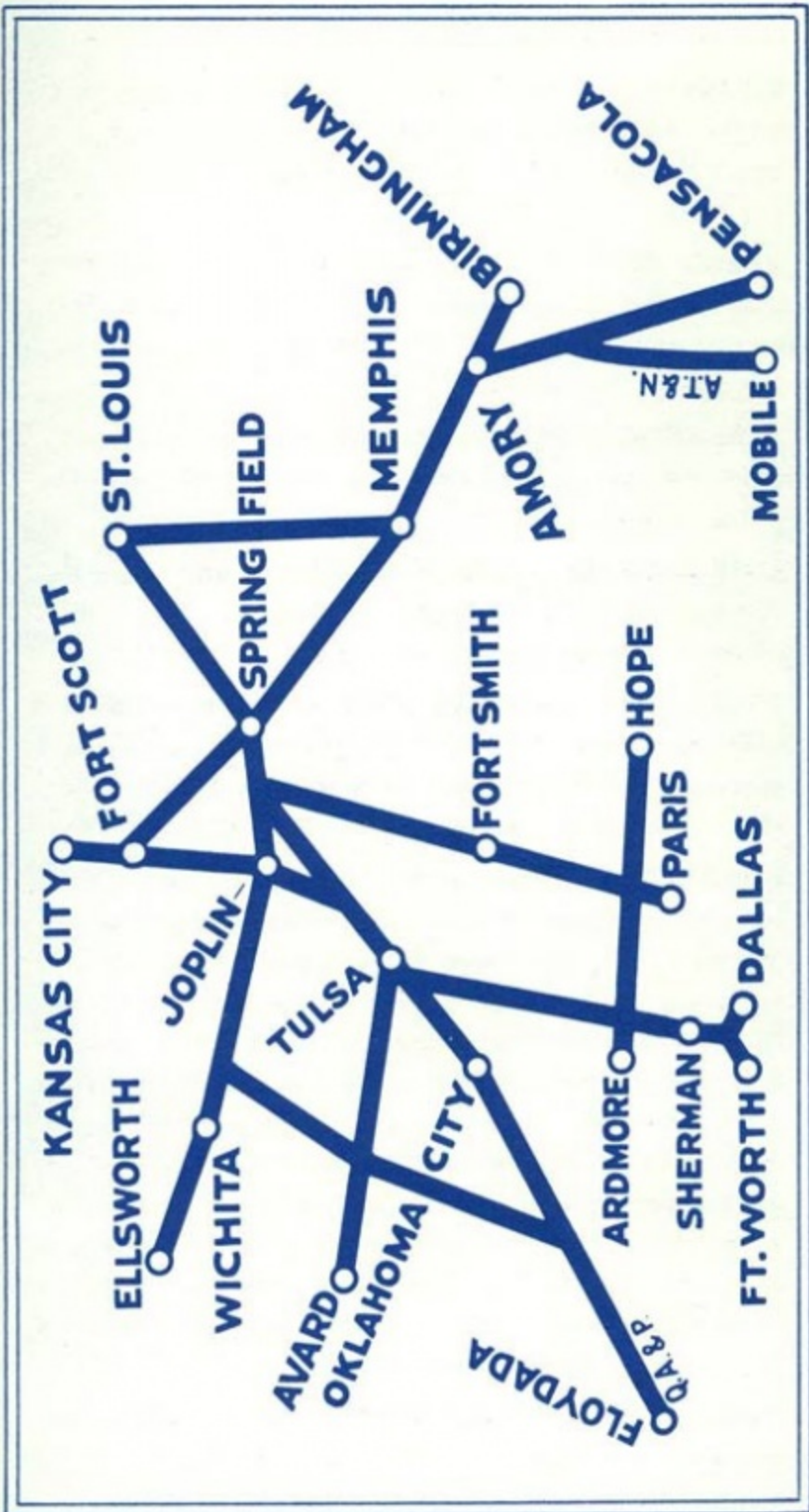

- +** — No baggage checked to or from this station.
- C** — Stops to let off revenue passengers from Springfield or beyond and on signal to take on revenue passengers.
- D** — Stops to let off revenue passengers, and on signal to take on revenue passengers for Springfield or beyond.
- E** — Stops to let off revenue passengers from Memphis or beyond, and on signal to take on revenue passengers for Birmingham or beyond.
- G** — Stops to let off revenue passengers from Birmingham or beyond, and on signal to take on revenue passengers for Memphis or beyond.

TIME — Central Standard time is used throughout this folder. A. M. time is shown in light faced figures and P. M. time in **dark** faced figures.

SCHEDULES — Shown herein are subject to change without notice and the Frisco assumes no responsibility for errors in time tables, inconvenience or damage resulting from delayed trains or failure to make connections.

STOPS — Trains will make stops only at stations where time is given or as indicated by special or conditional stops as shown in notes in this folder. Agents of this railroad or connecting line agents have no authority to change or vary from these conditions.

CHILDREN — Under five years of age free, when accompanied by parent or guardian; five years of age and under twelve, one-half fare; twelve years of age or over, full fare.

ADJUSTMENT OF FARES — In cases of misunderstanding with conductors or agents pay the fare requested, take receipt and communicate with Passenger Traffic Manager, Springfield, Mo. 65802.

REDEMPTION OF TICKETS — Tickets unused or partly used will be redeemed under tariff regulations at proper value.

LOST ARTICLES — To be inquired for by addressing the Passenger Traffic Manager, Springfield, Mo. 65802, direct or through nearest ticket agent.

PROTECTING PERSONAL EFFECTS — You are cautioned to carefully look after your luggage and personal belongings when carried on trains and in stations. As a reminder, the protection of these possessions is your responsibility.

BAGGAGE — On payment of a nominal baggage checking service charge (25¢ per piece of hand baggage and 50¢ per trunk) the Frisco Railway and connecting lines will check and transport your baggage in baggage cars. There is no additional charge for up to 150 pounds of baggage with value of not more than \$100.00 for each adult passenger and 75 pounds of baggage with value of no more than \$50.00 for child traveling on half-fare ticket. Baggage of greater weight or value will be handled on payment of proper tariff charges. No single piece of baggage exceeding 300 pounds in weight, or 72 inches in greatest dimension, or single shipment exceeding \$2,500.00 in value, will be checked.

DOGS, CATS and SMALL HOUSEHOLD PETS — Will be handled in baggage cars subject to tariff regulations and charges, and should be crated.
